#### **CLWYD VALE MOTOR CLUB PRIVACY NOTICE**

Clwyd Vale Motor Club respects your privacy and we will only use your information in the way we describe in this notice. When using your information, we aim to be fair and transparent and to follow our obligations under UK data protection laws. Your information is used for administering club membership, activities and competitions.

Clwyd Vale Motor Club is the data controller for the purpose of General Data Protection Regulations (GDPR) and the Data Protection Act 2018. #### **Collecting your information**

We collect your information when you fill in membership application or renewal forms and competition event entry forms. You can give us your information using paper forms or online forms. The information you give us may include your contact details (name, address, telephone number, email address), personal information and identifiers (date of birth, membership number, competition licence number), and other information (e.g. vehicle details). When you give us third party information, such as a child, parent, guardian, or emergency contact you should let that person know that you have given us the information.

If you are under 18 years old, we will also ask for appropriate information from your parent or quardian.

## **Using your information**

We use your information when you first apply to become a member of Clwyd Vale Motor Club, then to administer and renew your club membership, and provide you with details of member benefits. We also use your information when you enter club events. For competitions, we will publish some of your information in the event programme and results, which will also be made available in the public domain. Your information is used in these ways to fulfil our contract with you.

We may ask you for emergency contact and next of kin details which we will only use in an emergency, and which is used for a legitimate interest. You should let the contact and next of kin know that you have given this information to us

We might use your information to send you marketing messages by email, but only if you have agreed that we can do this by giving us your clear consent – and you can change your mind at any time just by letting us know. We will not sell your information to another organisation.

To support your lifetime relationship with motorsport and Clwyd Vale Motor Club we may keep your information indefinitely, unless you ask us to delete it.

## **Sharing your information**

We may share your information with Motorsport UK as required by its General Regulations for governing motor sport, with other Motorsport UK Registered Clubs, with medical personnel, or any other person if we have to comply with a legal obligation. We may also share your information with service providers, for example to print programmes or online entry hosting providers. In these cases, all of our service providers are located within the European Economic Area (EEA).

#### Our website

The club website might contain links to other websites such as online entry and payment sites, partners, and advertisers. If you follow links to other websites, please review the privacy policy for each site as we are not responsible for information you share on those sites.

## Security for your information

Your information is held securely by us. We have taken all reasonable steps and have in place appropriate security measures, to protect your information. Your information is not transferred outside the EEA.

## Your rights

You may ask us not to process your information for marketing purposes.

You are entitled to a copy of the information we hold about you, and to ask us to correct any inaccuracies.

You may ask us to stop using your information, and to delete it, although we maintain a skeleton set of your information. If you ask us to do this, we will not be able to continue our contract with you.
